| <i>Manual 522</i> | PSV - FT | Pastoral Service Full-Time <ul style="list-style-type: none"> • Elder, Deacon or Licensed Minister • Various levels of pastoral service in connection with a church • Works 30+ hrs/wk & earns at least 51% of their income from the church |
| | PSV - PT | Pastoral Service Part-Time <ul style="list-style-type: none"> • Elder, Deacon or Licensed Minister • Various levels of pastoral service in connection with a church • Works less than 30 hrs/wk & earns less than 51% of their income from the church |

 - Approved by the District Advisory Board and BGS
